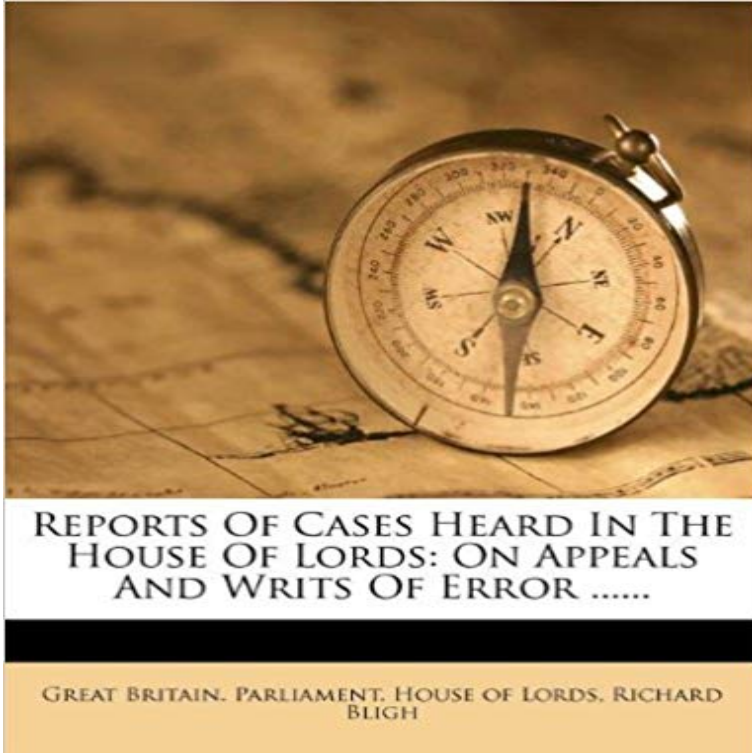


## Reports Of Cases Heard In The House Of Lords: On Appeals And Writs Of Error .....
